Rush Orders: WE DO NOT ACCEPT RUSH ORDERS. Credit cards require off-line processing and orders can take a day or more for complete processing. Expedited UPS shipping is available during the check-out process and products will ship using the selected service level. There is no guarantee that any order will ship on the day the order is placed.

Sales Tax: As American Solutions for Business operates throughout the United States had has a presence in all fifty states, applicable sales tax applies to all orders shipping to all locations in the U.S.A.
